#### GETTING STARTED

#### CUSTOMIZED PROGRAMS

CR&R offers waste audits for properties seeking to improve their current recycling and waste programs. A CR&R Sustainability Specialist will evaluate your waste stream from the inside out to achieve the most successful recycling program possible. #### RECYCLING CONTAINER

#### BULKY ITEMS, ELECTRONIC WASTE, & WHITE GOODS

Items that cannot properly fit in your container, such as a chair or desk, are considered bulky items and require a special pick up. Electronic waste [e-Waste] is anything with a circuit board or battery, such as computers, telephones and small printers. White goods [e.g. refrigerators, freezers] and electronic waste cannot be disposed of in your container. CR&R will collect and properly recycle these items. For pricing, please call customer service.

#### **HAZARDOUS WASTE/BATTERIES**

Hazardous wastes are products that are flammable, corrosive, reactive, or toxic. This includes batteries of all types, as they are considered hazardous waste in California when they are discarded. Therefore, it is illegal to dispose of them in regular trash or recycling; so don't place them in CR&R containers. This includes batteries of all types and sizes Alkaline (AAA, AA, C, D, 9 Volt), Lithium (button cell, power tool batteries, camera batteries, other electronics), Ni Cad (power tools), and other battery types both rechargeable and single use. Batteries must be taken to one of the following:

- household hazardous waste disposal facility
- universal waste handler
- local retailer (Home Depot, Lowes, Best Buy, Staples, Ikea, etc.)

Why is this important? When lithium batteries are improperly disposed of they can cause fires in recycling centers, landfills, and garbage and recycling trucks.

## RECYCLING LEGISLATION

# Assembly Bill 939 [AB 939]

required jurisdictions to meet diversion goals of 25% by 1995 and 50% by the year 2000.

# Assembly Bill 341 IAB 3411

requires all jurisdictions to meet the diversion goal of 75% by 2020 resulting in businesses that generate 4 or more cubic yards of waste to either:

- · Participate in a recycling program with their local waste hauler.
- Donate, sell and/or self-haul materials to a recyclina facility.

# **Assembly Bill 1826** [AB 1826]

requires properties to separate their green waste for recycling. AB 1826 builds on the success of the mandatory commercial recycling program established by AB 341. All properties with 5 or more units must either:

- · Participate in a recycling program with their local waste hauler.
- Donate, sell and/or self-haul materials to an organic recycling facility.
- Compost organic materials

# **Senate Bill 1383** [SB 1383]

In September 2016, Governor Brown signed SB 1383 establishing methane emissions reduction targets in a statewide effort to reduce emissions. In accordance to this law, all local jurisdictions must provide organic waste collection services to all residential and commercial generators by January 1, 2022, to divert this material from local landfills. Organic waste includes food scraps and green waste such as landscape and pruning waste.

#### RECYCLE PROGRAMS



#### MIXED RECYCLING

This program recycles materials such as: cardboard, mixed paper, plastic, aluminum and glass bottles. They may be mixed together and placed in a recycling bin.



#### **CONSTRUCTION AND DEMOLITION**

With construction and demolition [C&D] debris making up a large percentage of all material entering California landfills, CR&R can help you to divert as much as possible through a combination of source separation and mixed processing. Prior to starting your project, contact CR&R to find out what options will work best for your site. Planning ahead will assist you in diverting as much material as possible, as cost effectively as possible.



#### CHRISTMAS TREE RECYCLING

CR&R's Annual Christmas Tree and Holiday Greenery Recycling Program is an excellent way for apartment complexes, town homes, and home owners associations to effectively deal with the removal of additional holiday areen waste and eliminate overflow problems with your dumpsters. Your property can schedule to have a delivery of a roll-off bin to collect holiday green waste for recycling. The container

would remain on site through New Year's with a removal date the following week or later if requested. If the container becomes full prior to the removal date, you may call our Customer Service Department to order an exchange.
