

FILMING PERMIT APPLICATION INSTRUCTIONS

THE CITY OF ORANGE REQUIRES 16 WORKING DAYS TO PROCESS AN APPLICATION REQUEST.
INCOMPLETE PERMITS WILL NOT BE ACCEPTED.

AC	COMPLETED APPLICATION WILL CONTAIN THE FOLLOWING:
	Completed permit application (Form A pages 1-2).
	Certificate of insurance <u>AND</u> an endorsement naming the City of Orange as an additionally insured (see pages 8-9 sample) evidencing:
	 Workers compensation insurance as required by law for the protection of permittees' employees. Comprehensive or commercial general liability insurance written on an occurrence basis providing for a combined single limit of (a) \$1 million, or (b) \$500,000 per occurrence with \$1 million aggregate for bodily injury, death and property damage, or (c) \$1 million aggregate; and Automotive liability insurance on a comprehensive form covering all owned, non-owned and hired automobiles providing for a combined single limit of (a) \$1 million, or (b) \$500,000 per occurrence with \$1 million aggregate for bodily injury, death and property damage, or (c) \$1 million aggregate.
	Each policy of general liability and automotive liability shall be endorsed to provide that the City, its officers, agents, and employees are declared to be additional insureds under the terms of the policy.
	Copy of location agreement if filming on private property. The agreement must include the owner's contact information and signature.
	A draft of the neighborhood filming notification letter (Form B- page 3).
	Signatures of approval (Form C- page 4) from the immediate surrounding area of the proposed filming and parking locations.
	Film Set Questionnaire (Form D pgs 5-6). Please read through the list of conditions carefully.
	Filming layout diagram to include location to and equipment such as cameras, generators, etc., parking plan for vehicles such as trucks, vans, and personal crew vehicles.
	STUDENTS ONLY: City permits for productions involving weapons, requesting temporary traffic control, or additional safety personnel will not be approved.
	STUDENTS ONLY: Application must be reviewed for completion prior to submittal by an approved instructor, professor, etc.

^{**}Student filming is defined as a registered student at an accredited school engaging in film activities assigned by that school for an official class project and is covered by insurance provided by that school. Application Fees are also waived.

FILM PERMIT PROVISIONS

Permittee waives all claims against the City of Orange, its officers, agents and employees, for loss or damage caused by, arising out of, or in any way connected with the exercise of this permit. Permittee hereby agrees to indemnify, defend and hold the City, its authorized agents, officers, representatives and employees harmless from and against any and all losses, damages or claims, causes of action, costs, liabilities, penalties, judgments and expenses, including, without limitation, defense costs and reasonable legal fees, resulting from any and all claims or damage of any nature, including any accident, loss or damage to persons or property which the City may incur and which arise from or relate to any activity conducted by permittee or any of its officers, agents, employees, representatives, contractors, consultants, or students in connection with the rights granted in the permit or under Orange Municipal Code Chapter 5.45.

Permittee must comply with current state, local, and Cal/OSHA non-emergency standards pertaining to COVID-19.

City shall have the privilege of inspecting the premises covered by this permit at any or all times.

City may terminate this permit at any time if Permittee fails to perform any covenant herein contained at the time and in the manner herein provided. City agrees it will not unreasonably exercise this right of termination.

The parties hereto agree that the Permittee, its officers, agents and employees, in the performance of this permit, shall act in an independent capacity and not as officers, employees or agents of the City.

No alteration or variation of the terms of this permit shall be valid unless made in writing and signed by the parties hereto.

Permittee shall not discriminate against any employee or applicant for employment because of race, color, religion, ancestry, sex, age, national origin or physical handicap.

If Permittee is unable to film on scheduled date due to inclement weather, City must be notified in writing by next business day in order to reassign permit fees to a rescheduled date.

City shall be compensated for any loss or damage to City property by Permittee.

Permittee agrees to clean and restore the property to its original condition prior to use as a location site.

Public Use of City Park Facilities - - No vehicle(s) allowed on park turf areas. All film equipment must be transported via dolly or hand-carried in and out of park facility. No temporary parking of vehicle(s) on park turf for loading or unloading of equipment.

Permittee is responsible for fully complying with posted signage surrounding the requested film site. The City of Orange will not dismiss any citation issued to the Permittee or any person(s) associated with the film production who is in violation of posted regulations.

Permittee hereby agrees to comply with all the rules and regulations of the facility or institution subject to this permit.

Permittee hereby agrees to ensure compliance with the conditions of the permit, agrees to obtain prior City approval for deviations from the information provided herein and understands that failure to comply with these requirements may result in the immediate cancellation of filming.
